I/We agree as a condition of being allowed to use the ski area facility and premises, that I/We freely accept and voluntarily ASSUME ALL RISKS OF PERSONAL INJURY OR DEATH for property damage which results in any way from negligence, conditions on or about the premises and facilities, the operations of the ski area including, but not limited to, grooming, snowmaking, ski lift operations, actions or omissions of employees or agents of the area, or competitor's participation in skiing, training, any competitive event or any continuance thereof, or in the course of travel to or from any such even, or activities at the area.
